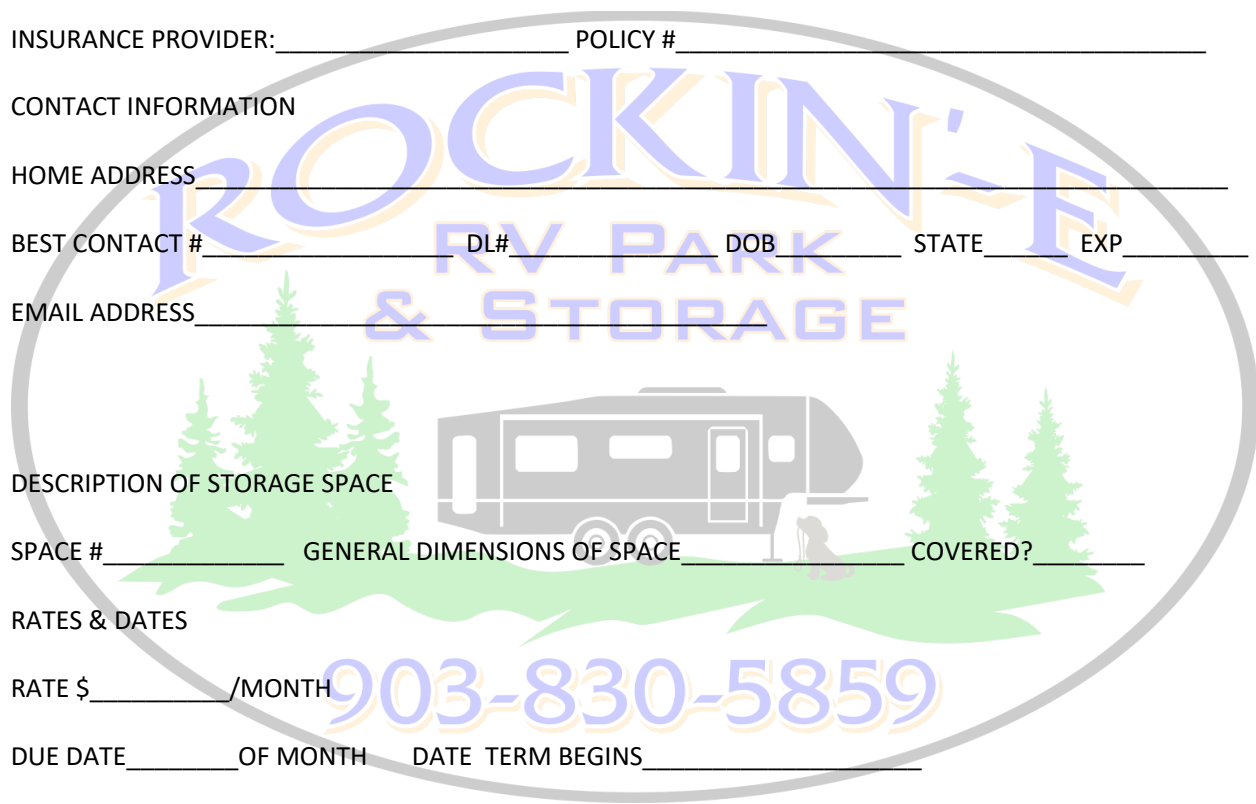

## RV / BOAT STORAGE TERMS & NOTICES

### 1. NOTICE & RELEASE

- a.) Rate is due in advance on the due date specified. Rate paid after due date will result in the late charges specified.
- b.) You are responsible for locking / securing your own property inside your RV / Boat
- c.) NO representations of safety or security have been made by Rockin' E RV. You hereby release Rockin' E RV and PWM Properties LLC from liability for all loss, damage, or cause of action of any nature, including but not limited to: bodily injury and damage to property stored in or transported to or from Rockin' E RV – Regardless who owns such property and regardless whether the loss or damage is caused in whole or in part by fire, smoke, dust, water, weather, insects, vermin, explosion, utility interruption, equipment malfunction, unexplained disappearance, negligence, or theft.
- d.) You are required to maintain full insurance coverage on your property at all times during the entire length of time you are renting the space.
- e.) Rockin' E RV has provided a reasonably secure space for the storage of your RV / Boat

### 2. TERM & RENEWAL

Rockin' E RV agrees to provide you the storage space described beginning on the date listed. You will have 24/7 access to your property during the dates agreed to. This agreement automatically continues on a month to month basis after the initial term ends until it is terminated in writing by you or by Rockin' E RV.

### 3. TERMINATION & MOVE-OUT NOTICE

Rockin' E RV requires notice in writing 10 days prior to ending this agreement. In the event this agreement is ended by Rockin' E RV, a 15 day written notice to the email and/or mailing address provided by you.

### 4. MOVE-OUT DUTIES

You are responsible for picking up any and all trash in your space before leaving. You will not remove any item from the Rockin' E RV property that does not belong to you.
